Dyffryn Arth Community Council Annual Report May 2024 - April 2025

Organisation of the Council

Dyffryn Arth Community Council is the most local tier of local government for the administrative Community of Dyffryn Arth and is a local authority established by way of the Local Government Act 1972.

The Council comprises ten elected Members representing two Wards.

The Members during the 2024-25 municipal year were:

Llanbadarn Trefeglwys Ward:

Councillors O Evans, C Harries, D W Jones and S Webster (elected unopposed May 2022)

Councillors R Fear and K Ratledge (co-opted after the election).

Councillor Ratledge resigned during the year for personal reasons.

Llanddewi Aberarth Ward:

Councillors J Ellis and A Davies (elected unopposed May 2022)

Councillors N Jones and G O'Connor (co-opted after the election).

Councillor Anne Davies resigned for personal reasons in May 2024.

Councillor Gwen Clements served during the period November 2024 – February 2025.

There remained two vacancies on the Council at the end of the municipal year.

Chairman: Councillor Sheila Webster

Vice-chairman: Councillor Rhian Fear

The Council employs a part-time Clerk and Responsible Finance Officer, Mr Denfer Morgan, who is responsible for the administration of the Council, including its finances.

The Council met at 8:00 pm on the second Monday of each month alternatively at the Aberarth Village Hall and the Pennant Community Centre. In accordance with the Local Government and Elections Act 2021, members of the public can attend meetings in person or by way of remote attendance using Microsoft Teams.

Ceredigion Community Review Final Recommendations

The Local Democracy and Boundary Commission published its Community Review Final Recommendations for Ceredigion and the decision was that Dyffryn Arth remains as a Community with a reduced number of seven Members, three for the Llanddewi Aberarth Ward and four for the Llanbadarn Trefeglwys Ward. This will be brought into effect by way of the May 2027 election.

Recreational and Amenity Land

The Council owns and maintains the Parc Hywel Teifi playground at Aberarth.

Services

Services provided by the Council include:

- Providing and maintaining the playground
- Keeping footpaths clear by way of regular strimming by a contractor

Projects

The following project were considered during the year:

Provision of street lights outside Swn yr Efail, Pennant. This project did not proceed due to the unavailability of suitable land.

Provision of street light at Aberarth – in progress.

Finance

The Council sets an Annual Budget at its January meeting which outlines its proposed expenditure for the following financial year in respect of the services it intends to provide and the projects it intends to undertake during the year. This expenditure is funded by way of a precept which is approved at the same meeting. The precept, in turn, is raised by way of a Council Tax payable by each dwelling within the Community. Other sources of income are also used together with reserves.

The Council's budget for 2024-25, set at its Meeting held on 8th January 2024, was as follows:

Expenditure - £14,550

Income - Precept: £14,550

Council Tax at Band D - £24.11

Annual Accounts

The Annual Accounts for 2024-25 were sent to Audit Wales for auditing.

Community Matters

Representing the Community

Ceredigion County Council is the local education authority, local highways authority, local planning authority and is responsible for the provision of social services for the County. The Community Council is consulted by Ceredigion County Council on certain matters.
