### 182 Gwasanaeth Cludiant Cymunedol Dolen Teifi

Croesawyd i'r cyfarfod Rod Bowen o Dolen Teifi a Emma Bingham, Swyddog Datblygu Cymdeithas Cludiant Cymunedol Cymru. Cafwyd amlinelliad gan Mr Bowen o'r gwasanaethau amrywiol a ddarparwyd gan y Fenter yn Sir Gâr a Cheredigion, yn enwedig ers i'r Cynllun Bwcabus ddod i ben. Roedd y mathau o wasanaethau a ddarperir ar gyfer y cyhoedd, cyrff lleol a theluoedd, yn cynnwys bysiau mini i'w hurio, cludiant cymunedol ac i ysbytai a hyfforddiant rhad ac am ddim i wirfoddolwyr i yrru cerbydau. Fe amlinellodd Ms Bingham gwaith y Gymdeithas yn cefnogi mentrau lleol drwy Gymru benbaladr, a oedd i gyd nid er elw.

Yn dilyn trafodaeth am faterion lleol, gan gynnwys cefnogaeth i gartrefi gwarchod, **PENDERFYNWYD** nodi'r gwybodaeth a ddarparwyd ac i gadw mewn cof y gwasanaeth a ddarperir gan Dolen Teifi yn ystod trafodaethau yn y dyfodol am ddarpariaeth cludiant yn y gymuned.

### 183 Darparu Biniau Halen

### 182 The Dolen Teifi Community Transport Service

Rod Bowen of Dolen Teifi and Emma Bingham, the Development Officer for the Community Transport Association in Wales were welcomed to the meeting.

Mr Bowen outlined the various services being provided by the Initiative in Carmarthenshire and Ceredigion, in particular following the cessation of the Bwcabus scheme. The type of services being provided, for the public, local organisations and families, included mini buses for hire, community and hospital journeys and free training of volunteers for driving vehicles.

Ms Bingham outlined the work of the Association in supporting local initiatives throughout Wales, all of which were not for profit.

Following discussion about local issues, including support for sheltered housing, it was **RESOLVED** to note the information provided and to bear in mind the service being provided by Dolen Teifi in future discussions about transport provision in the community.

### 183 Provision of Salt Bins

The Clerk advised that information had been received from the County Council that community salt bins were available for the supply and delivery for £240 and an estimate of £150 for the future filling of bins in the future.

It was **RESOLVED:**

- i) to purchase six bins for use in the locations in the Community; and
- ii) to include provision in the 2024-25

A discussion ensued as to the visit by Officers of the Dŵr Cymru Water Division with Councillor Ellis and the opportunity taken by him to report the condition of the road serving the outfall; and the appearance of workmen the following day in making temporary repairs. Hopefully this indicated that they had now taken responsibility for the road. Councillor Evans stated that she would continue to request Dŵr Cymru to visit the outfall.
