Clerk on the three replies received from the seven house owners at Swn yr Efail, Pennant who had been consulted with regard to the proposal to place two street lighting columns along the front of their houses.

The replies received were noted and reference was made to the original representations received from some of the residents requesting street lighting.

Following discussion, it was **RESOLVED** to proceed with the proposal subject to changing the location of the lighting column at the western end to a more central position.

**201 Report of County Councillor Elizabeth Evans**

The following information was provided by Councillor Evans in respect of the Llanddewi Aberarth Ward:

- She was continuing to share information publicly on any disruptions to the household waste collection.
- Pear trees had been planted on the land at the junction near Rosehill
- The requests for a street light on the bridge and the provision of a bin were still being followed up.

**202 Report of County Councillor Keith Henson**

The following information was provided by Councillor Henson.

- Pot-holes and flooding instances were being reported on a regular basis.
- A meeting had been held with representatives of NMWTRA involving all County Councillors with the A487 trunk road in their wards
- A meeting had been arranged with Lee Waters, the Deputy Minister for Climate Change, in respect of a possible replacement scheme in the south of the County following the discontinuation of the Dolen Teifi service.
