209 Cynigion Drafft Adolygiad Cymunedol Ceredigion

Rhoddiwyd ystyriaeth i Gynigion Drafft Adolygiad Gymunedol Ceredigion ar gyfer y Gymuned hon, sef:

- nid oedd yna newidiadau i ffiniau yn cael eu cynnig (ar wahan i rai bach er mwyn tacluso rhai ardaloedd bach)
- bod y ddu Ward – Llanbadarn Trefeglwys a Llanddewi Aberarth yn parhau
- yn unol â Pholisi Maint y Cyngor a gymeradwy-wyd gan y Cyngor Sir ar gyfer yr Adolygiad, sef “ni ddylai cymuned gynnwys llai nag 800 o etholwyr yn gyffredinol...a chael ei chynrychioli gan 7 cynghorydd o leiaf” roedd yn cael ei gymeradwyo fod gan y Cyngor Cymuned 7 Aelod. – 4 ar gyfer Llanbadarn Trefeglwys a 3 ar gyfer Llanddewi Aberarth.

Mynegodd yr Aelodau eu siom gyda'r argymhellion gan eu bod o'r farn nad oeddent yn gwella'r trefniadau democraidd presennol ac eu bont yn tanseilio "llywodraeth leol effeithiol a chyfleus" ar gyfer etholwyr y Gymuned. Hefyd, roedd Cyngor Sir Ceredigion yn gofyn i'r Cyngor Cymuned, oherwydd pwysau cyllidebol, ddarparu mwy a mwy o wasanaethau o fewn y gymuned. Roedd o'r farn taw canlyniad lleihau'r nifer aelodau i saith fyddai:-

- llai o gynrychiolaeth i etholwyr mewn ardal wledig eang
- gyda chworpwm o draean, fe fyddai cyfarfod o'r Cyngor yn ddilys o ran cworpwm gyda thri Aelod yn unig yn bresennol sy'n llawer rhy fach i ddarparu fforwm ddemocraidd iach ar gyfer penderfynnu materion lleol a darparau gwasanaethau
- gyda mwy a mwy o wasanaethau yn cael eu trosglwyddo gan y Cyngor Sir i'r Cyngor Cymuned,

awaiting a reply.

Ceredigion Community Review Draft Proposals

Consideration was given to the Ceredigion Community Review Draft Proposals and the recommendations for this Community namely:

- there are no boundary changes proposed (other than very minor ones to tidy up some small areas)
- the two wards - Llanbadarn Tre-feglwys and Llanddewi Aberarth will remain
- in accordance with the Council Size Policy approved by the County Council for the Review, namely "a community in general have no fewer than 800 electors and be represented by a minimum of 7 councillors", it was being proposed that the Community Council has . has 7 Members - 4 for Llanbadarn Trefeglwys and 3 for Llanddewi Aberarth.

Members expressed their disappointment with the recommendations as they were of the view was that they did not improve the existing democratic arrangements and that they undermined "effective and convenient local government" for the electors in the Community. Also, the Community Council was being asked by Ceredigion County Council, due to budgetary pressures, to provide more and more services within the community.

It was of the opinion that a reduction in the number of Members to seven would result in:-

- less representation for electors in a large rural area
- with a quorum of a third, a Council meeting would be quorate with only three Members in attendance which is much too small to produce a healthy democratic forum for determining local matters and providing services
- with more and more services being
